

ULPA – LPI CONFERENCE INFORMATION

Monday, February 27 – Saturday, March 3, 2012

Attendees: To attend the ULPA/LPI 2012 Annual Conference, please complete the enclosed registration form and mail it to the ULPA office with your check or fax it to the ULPA office at 847-362-6443 with your credit card information. The ULPA office is handling all registrations this year.

The registration fee for the conference is \$450 for ULPA/LPI members who are staying at the Palm Beach Marriott Singer Island Beach Resort & Spa and \$500 for non-members staying at the Palm Beach Marriott Singer Island Beach Resort & Spa. The conference registration fee covers all ULPA/LPI conference events with exception of hotel accommodations.

Spouses and Guests: Spouses and guests may register, on an a la carte basis, for various conference functions. Details are listed on the registration form.

Hotel Accommodations: The conference for 2012 has been booked at the Palm Beach Marriott Singer Island Beach Resort & Spa. It is located at 3800 North Ocean Drive, Riviera Beach, Singer Island, FL 33404. Their website is www.palmbeachmarriottresort.com. The room rates will be \$209 per night with NO resort fee. Call the hotel at 877-239-5610 and mention the booking name "ULPA/LPI".

A Hospitality Suite will be available at the hotel on Wednesday evening beginning at 5:00 pm. You may pick up your information packets there as well as enjoy hors d'oeuvres and beverages.

The Thursday evening activity will be Sunset @ Sailfish. On Friday evening we'll enjoy the ULPA/LPI Banquet with the evening beginning with cocktails followed by dinner and a brief awards presentation.

Transportation: The Palm Beach Marriott is located approximately 13 miles from the Palm Beach International Airport. There is no shuttle service to the hotel. A one way taxi ride is approximately \$45.00. The hotel does offer on site parking for \$20.00 per day.

LPI Certification Testing: The LPI will have available, onsite at the ULPA/LPI 2012 Annual Conference, 4 LPI proctored testing sessions for individuals seeking Journeyman (2 tests), Master Installer (2 tests), Master Installer Designer (1 test) and Designer Inspector (2 tests) certifications. These sessions are as follows:

12:30 pm – 3:00 pm Wednesday, February 29

3:00 pm – 5:30 pm Wednesday, February 29

8:00 am – 10:30 am Saturday, March 3

10:30 am – 1:00 pm Saturday, March 3

All tests must be completed in a 2 (two) hour time limit with the exception of the Master Installer tests which allow 2 ½ (two and one half) hour time limit. Only one test may be taken per 2 hour/2 ½ hour testing limit.

To sign up: to take tests during any LPI proctored sessions, you must first register with the LPI office as follows:

- 1) Visit the LPI website, www.lightning.org for Certification Test information and to print out the registration form.
- 2) Complete the Registration Form (write "Annual Conference" in proctor information area) and return it to the LPI office with payment of test fees by **January 25, 2012**.
- 3) Be sure to bring the appropriate pencils, ruler, etc. you may need to complete your tests on site.
- 4) Call the LPI office at 800-488-6864 if you have questions.

\$75.00 per test for non-members
